



Budenberg Standard Warranty Terms

Budenberg Gauge Co. Ltd. warrants its goods to be free from defects in workmanship or material under normal use and service for the given period as listed below. The warranty period is effective from the date of shipment and Budenberg Gauge Co. Ltd. undertakes to repair or replace any parts which prove to be defective within said warranty period provided that the instruments have been returned carriage paid to our factory. Said warranty service may only be obtained by returning to our factory with proof of purchase by way of an invoice or similar documentation.

This warranty does not apply if any warranty or warning labels – or seals of any type – have been removed, damaged or tampered with or if the instrument or equipment has been abused, altered, disassembled, used at ratings above the maximums specified or otherwise misused in any way.

No representation or warranty is given as to the suitability or fitness of the goods for any particular purpose and the buyer shall satisfy itself in this respect and be totally responsible therefore. All technical advice, recommendations and services provided by Budenberg Gauge Co. Ltd. are based on the belief that the technical data and information provided by the buyer is reliable and intended for use by persons having the necessary skills and knowledge of the business. Budenberg shall, in no event, be liable for any incidental or consequential loss – including loss of profits – in respect of product failure.

Re-calibration or service work of any kind carried out by any other service or product provider during the warranty period of the product will invalidate the warranty and subsequently any claim.

Non-Warranty Repair or Product Re-test / Evaluation

Products returned for assessment, repair or overhaul are subject to a repair and / or re-test charge. A purchase order authorising repair or re-test / evaluation must be issued to Budenberg in advance of any work being carried out.

When the product is returned to the company for non-warranty work then an order must be issued within 3 months of the date of said return; in the event that an order is not placed within this time period, then Budenberg retains the right to dispose of the product.

Customer services will provide a quotation for the repair or evaluation but cannot provide any technical report until an order is received to carry out the work.
